## NOTICE

It is hereby notified for general information of all concerned that the DRIEMS INSTITUTE OF HEALTH SCIENCES AND HOSPITAL was established in the year 2023 after receiving the Letter of Permission from NMC on 01<sup>st</sup> June 2023 for 100 MBBS seats and subsequently we have taken admission for 100 students for the academic Year 2023-24. As per the NMC guidelines, we formed an internal committee and proposed Fees of Rs 18,50,000/- (Eighteen Lacs Fifty thousand) per annum for MBBS course to Govt of Odisha. But, the admission to the MBBS course for the academic year 2023-24 was done through OJEE in the old fee structure without taking into the consideration of our fee proposal in line with the NMC Guidelines to fix Course fee for new Medical Colleges.

The DRIEMS University was established on 15.11.2023 as per the DRIEMS University Odisha Act, 2022 (Odisha Act 6 of 2023). Section 36 (1) of the Act empowers the University to constitute a Fee Structure Committee as per norm of regulatory bodies to determine the fees for imparting different programs run by University.

Accordingly, the Fee Structure Committee of DRIEMS University was constituted under the Chairmanship of Honorable Shri Justice Bira Kishore Misra, former Judge of Odisha High Court and former Chairperson, Human-Rights Commission to decide Fees for the different Programs taking into account the various factors within the regulatory framework. In case of MBBS course, before finalizing the fees, the Committee took reference from NMC guideline vide office memorandum dated 3<sup>rd</sup> February 2022 for calculation of cost input & inflation. As per the NMC guidelines, the new Medical Colleges should fix their fee structure in line to nearby Medical Colleges established in its periphery. The Fee Structure Committee after due deliberation fixed the fees of the MBBS course for the academic year 2024-25 at Rupees 18, 50,000 (Eighteen lakh fifty thousand) per annum The same was notified on 01.03.2024 in the MOM of FSC .The course fee does not include the hostel fees, uniform, examination and alumni association fees. However the fees for the student of NRI shall be four times of the normal fees.

The University has communicated the proceedings of the Fee Structure Committee to Govt. of Odisha in SD &TE department, DMET Odisha, OJEE Odisha vide letter no DMRU/00606/2024 and DMRU/00605/2024 dated 05.03.2024 respectively.

We expect the OJEE to publish our fee structure in its website very soon. In case the OJEE fails to notify the same in its website within stipulated time, the University will take admission of MBBS students through OJEE but the differential amount after counselling will be deposited at the Medical College at the time of admission in form of demand draft by the students.
